## Course Description

This online course will provide best practices for the therapeutic management of major opioid use disorders for all patient populations, with a special focus on interprofessional work practices to improve quality of care. Faculty will discuss current and emerging issues related to substance misuse behaviors and trends.

## MATE Law Information

DEA-registered practitioners who are renewing their license or any first-time registrants are required to complete eight hours of training “on the treatment and management of patients with opioid or other substance use disorders.” Practitioners who are solely veterinarians are exempt from this requirement.

You have already met this requirement if you are:

- board certified in addiction medicine or addiction psychiatry by the American Board of Medical Specialties, the American Board of Addiction Medicine or the American Osteopathic Association
- a graduate in good standing from a U.S. medical, dental, physician assistant or advanced practice nursing school within five years of June 27, 2023, who successfully completed eight hours of training on treating and managing patient with treating and managing patients with opioid and other substance use disorders, including the appropriate clinical use of all drugs approved by the Food and Drug Administration for the treatment of a substance use disorder

Practitioners may count past trainings from relevant providers including the DATA-2000 Waiver training, toward the eight-hour requirement.

## Course Format

This self-paced course will be available online beginning July 31 at [CMEVillage.com](https://www.cmevillage.com). Participants may complete some or all of the eight (8) modules, based on their interests and needs. Credit will be awarded based on participation, with one content hour per module.

## Target Audience

This course has been developed for Physicians, Nurses, Physician Assistants, Psychologists, Social Workers, Pharmacists, and other healthcare team members, especially those renewing a DEA license who need to fulfill MATE law requirement for 8 hours of accredited substance abuse education.

### Accreditation

In support of improving patient care, the University of Virginia School of Medicine and School of Nursing is jointly accredited by the Accreditation Council for Continuing Medical Education (ACCME), the Accreditation Council for Pharmacy Education (ACPE), and the American Nurses Credentialing Center (ANCC), to provide continuing education for the healthcare team.

This activity was planned by and for the healthcare team, and learners will receive up to **8 hours of Interprofessional Continuing Education (IPCE)** credit for learning and change.

### Physicians
